

# SAC AND FOX NATION SEX OFFENDER ACKNOWLEDGEMENT FORM

## Notice of Duty to Register

1. I have been given a copy of the Sac and Fox Nation of Oklahoma Sex Offender Registration Code.
2. I understand that I have a legal duty to register as a sex offender with the Sac and Fox Nation of Oklahoma and the county law enforcement agency having jurisdiction over my place of residency. I am responsible for obtaining and submitting the information required of me for the registration paperwork.
3. Individuals who have been convicted of a qualifying sex offense as outlined in the Sac and Fox Nation of Oklahoma Sex Offender Registration Code or the Federal Sex Offender Registration and Notification Act must register as a sex offender with the Sac and Fox Nation of Oklahoma if:
  - a. The sex offender(s) was convicted and incarcerated by the tribe of the qualifying offense,
  - b. The sex offender(s) resides within the exterior boundaries of the Sac and Fox Nation of Oklahoma or otherwise reside on property owned by the Sac and Fox Nation of Oklahoma in fee or trust regardless of location,
  - c. The sex offender is employed (including volunteer work) by the Sac and Fox Nation of Oklahoma in any capacity or otherwise are employed within the exterior boundaries of the tribe or on property owned by the Sac and Fox Nation of Oklahoma in fee or trust regardless of location, or
  - d. The sex offender is a student, in any capacity, within the exterior boundaries of the Sac and Fox Nation of Oklahoma or on property owned by the Sac and Fox Nation of Oklahoma in fee or trust regardless of location.
  - e. The sex offender receives health care, social services, etc. that are available by the Sac and Fox Nation of Oklahoma.
4. Sex offenders required to register with the Sac and Fox Nation of Oklahoma shall complete a sex offender registration form and shall otherwise provide the Sac and Fox Nation Police Department with the following information: criminal history, date of birth, DNA samples, driver's licenses, identification cards, passports, and immigration documents, employment information, finger and palm prints, internet identifiers, name, phone numbers, picture, physical description, professional licensing information, address (residential and mailing), school information, social security number, temporary lodging information, conviction offense information, and vehicle information
5. Pursuant to Sac and Fox Nation of Oklahoma and federal laws, anyone who is required to register with the Sac and Fox Nation shall do so in the following timeframe:
  - a. If incarcerated, before release from imprisonment for the registration offense
  - b. If not incarcerated, within 3 business days of sentencing for the registration offense, and
  - c. For foreign, federal, and military convictions, a sex offender must appear in person at the Sac and Fox Nation Police Department within 3 business days of establishing a residence on the reservation or tribal property after either release from incarceration or, if not incarcerated, sentencing for purposes of complying with the 2006 Adam Walsh Child Protection and Safety Act, P.L. 109-248 or the Federal Sex Offender Registration and Notification Act.

6. All sex offenders required to register with the Sac and Fox Nation of Oklahoma must immediately appear at the Sac and Fox Nation Police Department in person to update any change in their name, residence (including termination of residence), employment, school attendance, vehicle information, temporary lodging, email addresses, telephone numbers, Instant Messaging addresses, and any other designation used in internet communications, posting, or telephone conversations. In the event of a change in temporary lodging, the sex offender shall immediately notify the jurisdiction in which the sex offender will be temporarily staying.
  
7. All sex offenders who are employed by the Sac and Fox Nation of Oklahoma in any capacity or otherwise are employed within the exterior boundaries of the reservation or on property owned by the Sac and Fox Nation in fee or trust regardless of location that change or terminate their employment shall immediately appear in person at the Sac and Fox Nation Police Department to update their information.
  
8. Any sex offender who is a student in any capacity within the exterior boundaries of the reservation or on property owned by the Sac and Fox Nation in fee or trust regardless of location change their school, or otherwise terminate their schooling, shall immediately appear in person at the Sac and Fox Nation Police Department to update that information.
  
9. A sex offender who is or should be registered with the Sac and Fox Nation of Oklahoma shall at a minimum appear in person at the Sac and Fox Nation Police Department for purposes of keeping registration current in accordance with the following time frames:
  - a. For Tier 1 offenders, once every 90 days for the rest of their lives,
  - b. For Tier 2 offenders, once every 90 days for the rest of their lives,
  - c. For Tier 3 offenders, once every 90 days for the rest of their lives.
  
10. At each in person verification a sex offender shall permit the Sac and Fox Nation Police to take a current photograph of the offender, and shall review existing information for accuracy.
  
11. The following information, related to the sex offender, will be maintained on Sac and Fox Nation Sex Offender Public Website: any registration requirement violations, if absconded, all sex offenses for which convicted, all sex offenses for which registered, address of employer, current photograph, physical description, residential address including habitual residences, all addresses of schools attended, and vehicle license plate number along with a description of the vehicle.
  
12. Failure to comply with my sex offender registration requirements, including failure to update my current registration and/or failure to register as a sex offender if I move to, work in or attend school in another state or foreign country, could be a violation of the Adam Walsh Act (Sex Offender Registration and Notification Act), 18 U.S. C. section 2250.

13. All sex offenders who are employed by the Sac and Fox Nation of Oklahoma in any capacity or otherwise are employed within the exterior boundaries of the reservation or on property owned by the Sac and Fox Nation in fee or trust regardless of location that change or terminate their employment shall immediately appear in person at the Sac and Fox Nation Police Department to update their information.
14. Any sex offender who is a student in any capacity within the exterior boundaries of the reservation or on property owned by the Sac and Fox Nation in fee or trust regardless of location change their school, or otherwise terminate their schooling, shall immediately appear in person at the Sac and Fox Nation Police Department to update that information.
15. A sex offender who is or should be registered with the Sac and Fox Nation of Oklahoma shall at a minimum appear in person at the Sac and Fox Nation Police Department for purposes of keeping registration current in accordance with the following time frames:
  - a. For Tier 1 offenders, once every 90 days for the rest of their lives,
  - b. For Tier 2 offenders, once every 90 days for the rest of their lives,
  - c. For Tier 3 offenders, once every 90 days for the rest of their lives.
16. At each in person verification a sex offender shall permit the Sac and Fox Nation Police to take a current photograph of the offender, and shall review existing information for accuracy.
17. The following information, related to the sex offender, will be maintained on Sac and Fox Nation Sex Offender Public Website: any registration requirement violations, if absconded, all sex offenses for which convicted, all sex offenses for which registered, address of employer, current photograph, physical description, residential address including habitual residences, all addresses of schools attended, and vehicle license plate number along with a description of the vehicle.
18. Failure to comply with my sex offender registration requirements, including failure to update my current registration and/or failure to register as a sex offender if I move to, work in or attend school in another state or foreign country, could be a violation of the Adam Walsh Act (Sex Offender Registration and Notification Act), 18 U.S. C. section 2250.
